**RES AGA 41/1**

**Noting** with great satisfaction the efforts expended in the preparation of this Assembly and the warm hospitality accorded to the delegates by the President of AFRAA and CEO of Mozambique Airlines (LAM) and the management and staff of Mozambique Airlines

**Be it resolved that**

The annual budget and membership subscriptions for the year 2010 be and are hereby approved as submitted to the Assembly subject to making the adjustment to take into account the additional cost related to the transition period between the out going and incoming Secretary Generals.

The budget to be readjusted after taking into consideration the contribution of those members who may not be in operation.

**APPRECIATION OF THE SERVICES OF  
MR. CHRISTIAN FOLLY-KOSSI**

**RES AGA 41/5**

**Recognizing** the 10 years of dedicated and loyal service of Mr. Christian Folly-Kossi as the Association Secretary General and his outstanding contribution to the building of the image and stature of the African Airline Association as a leader and key player in African Aviation.

**Considering** the contribution made during this period by Mr. Christian Folly-Kossi towards the development of commercial aviation in Africa, particularly in the area of cooperation among African carriers,

**Noting** that Mr. Folly Kossi will shortly be leaving AFRAA after a distinguished career in the air transport industry,

**Mindful** of the need to recognise the services of Mr. Christian Folly-Kossi to the Association,

**Resolves:**

- a) To publicly record its appreciation and gratitude to Mr. Christian Folly-Kossi for his contributions to the development of African air transport and in particular for serving the Association with diligence, dedication and loyalty;
- b) The Executive Committee in due course will decide on how to translate into practical terms the form in which this appreciation will take.

**Recalling the** resolution adopted by the 39<sup>th</sup> AGA on the great threat the African aviation industry is facing as a result of the flight of highly skilled and professional manpower and the need for urgent action,

**Noting** with concern that very little action if any has been taken so far by African governments and stakeholders and the threat still continues,

**Noting** with satisfaction the conclusions and recommendations of the 1<sup>st</sup> conference on “Brain Drain in African Aviation” convened by AFCAC in 2009 in Addis Ababa,

**Convinced** of the urgent need to implement these recommendations if brain drain is to be mitigated

**Resolves:**

**To once again call** on African governments to put in place national policies and regulations that encourage retention of existing professional manpower in the aviation sector and facilitate the return of those in the diaspora

**To call upon** African governments, the AU, AFCAC and member airlines and other stakeholders to work together to implement the recommendations of the conference on Brain Drain in African aviation including:

1. The creation of one, single, comprehensive database comprising all aviation education and training centers and aviation professionals within Africa and in the diaspora
2. The standardization, harmonization and rationalization of all aviation education and training and the designation of Regional Centers of excellence
3. The establishment of secure and transparent African Aviation Manpower Development Fund
4. The intensification of cooperation by aviation training centers in Africa as well as partnerships and strategic joint ventures with aviation centers of excellence around the world.

**European Union – Emissions Trading Scheme (EU-ETS)**

**RES AGA 41/7**

**Aware** effective January 2012 emissions resulting from virtually all flights to from and within the EU will be included in the EU Emission Trading Scheme,

**Aware** that the majority of African Carriers operating to EU countries will be covered under the EU-ETS Scheme despite the minimum threshold set by EU Regulation,

**Recognizing** the EU-ETS is contrary to principles of international law and not accepted by the majority of states outside the EU,

**Noting** with concern despite the worldwide opposition the EU has recently required that all airlines covered by the Scheme to submit their emission recording and reporting plan in preparation for 2012 application of the Scheme,

**Resolves to:**

**Call Upon** African Governments to continue to oppose any unilateral imposition of environmental charges by State on international air transport.

**Call on** the AU, AFCAC and Regional Economic Communities (RECs) to work together and establish a common African position relating to the EU-ETS

**Recommend** that member airlines which submit their ETS plan pursuant to the EU guidelines to do so under ‘protest’.

Urge African governments to promote a global sectorial approach to aviation environmental impact under the leadership of ICAO.

## **COOPERATION AMONG AFRICAN**

**RES AGA 41/8**

**Recalling** the repeated calls for cooperation among African carriers by this Assembly and the various efforts of AFRAA in this area,

**Encouraged** by the growing trend towards increased cooperation among various African airlines despite the various barriers to cooperation.

### **Resolves to:**

**Commend** and welcome the cooperation initiatives taken by these airlines

**Call upon** all member airlines to further intensify their effort to establish cooperation among themselves.

Urge African governments to create a conducive legal and political environment and facilitate cooperation among African carriers.

**Direct** the Secretariat of AFRAA to continue to vigorously promote cooperation among member airlines, provide necessary assistance in facilitating cooperation and sensitize the African governments on the need to provide a conducive environment that will nurture and support cooperation among African carriers.
